A landmark development in virtual assets, and Bitcoin in particular, occurred in January 2024 when the U.S. Securities and Exchange Commission (SEC) approved the first-ever batch of spot Bitcoin ETFs. This milestone added more legitimacy to this new asset class. Together with its financial performance and portfolio diversification characteristic, more family offices and HNWIs are also increasingly allocating small % of their portfolios into this new asset class.

Meanwhile, HKMA unveiled Project Ensemble to support of development of Real World Asset (RWA) tokenisation in March 2024. This initiative also accelerated the participation in digital assets by major financial institutions, technology leaders, fintechs, etc

This seminar is intended to showcase a summary of the major industry development taken place to date from both a supply and demand perspective, highlighting key motivations behind why investors are attracted to the new asset class, and key opportunities for financial institutions, corporates, startups, investors in Hong Kong going forward.

Prior to taking up this role, Ms Wong worked in the Investment Products Division and the Intermediaries Supervision Department and played a key role in Commission-wide policy initiatives including developing and enhancing Hong Kong as an international asset management centre and introducing guidelines for regulating the sale of investment products through online distribution and advisory platforms.

Ms Wong practised as a banking and finance lawyer in Hong Kong prior to joining the Commission.
