#### The webinar will cover:

This webinar will focus on a range of collective investment schemes, their impacts on the Trustee Industry in Hong Kong and development of the Greater Bay Area (GBA), as a key growth driver for the industry.

The Hong Kong Open-ended Fund Companies (OFC) and Limited Partnership Funds (LPF) regime are all serving to increase Hong Kong's attractiveness as a fund domicile of choice. We expect both the OFC and LPF to be popular vehicle for Chinese, Hong Kong and foreign fund managers looking to manage Asian capital and bring operation and investment structure onshore.

In the webinar, we shall share the latest updates on the OFC and LPF Fund regime together with other development.

In addition, we will discuss the SFC's Pooled Retirement Funds (PRF) Code and highlight key impacts to the funds and trustee industry.

The Hong Kong Government has introduced the above initiatives to drive further growth of the asset management sector and to strengthen the status of Hong Kong as the international leading asset and wealth management hub. This will further attract talent and professional services to the region.
