Keynote Speaker



Mr. Christopher Hui, GBS, JP
Secretary for Financial Services and the Treasury

Mr Hui has been Secretary for Financial Services and the Treasury since 2020. He serves on the boards of Mass Transit Railway Corporation Limited, Hong Kong Airport Authority and also as the Chairman of the Kowloon-Canton Railway Corporation.

He was an Administrative Officer in the Government from 1999 to 2003 and served in the Economic Development Branch, the Office of the Government of the Hong Kong Special Administrative Region in Beijing and the Home Affairs Department. After leaving the Government, Mr Hui spent 13 years at the Hong Kong Exchanges and Clearing Limited, having been the Managing Director for Market Development and Head of Project Management and also in various senior roles in Listing and Market Development. He worked for a number of multi-national companies in the private sector as well. He was appointed the Executive Director of the Hong Kong Financial Services Development Council from 2019 to 2020.

Mr Hui previously held a number of public roles including Councillor of the City University of Hong Kong, Member of the Mandatory Provident Fund Schemes Authority Process Review Panel, Hong Kong Stock Exchange Listing Review Committee and also Hong Kong Institute of Certified Public Accountants Disciplinary Panel.

Mr Hui holds Bachelor and Master (Hon) Degrees in Philosophy, Politics and Economics from the University of Oxford, and Master of Business Administration Degree from INSEAD. He also attended the Stanford Executive Programme (SEP).

Ms Choi is a member of the Securities and Futures Commission (SFC). She is also an Executive Director with responsibility for the Investment Products Division, which is responsible for authorising and supervising collective investment schemes and other investment products as well as for the development and implementation of the SFC's asset management strategy and policies.

Ms Choi joined the SFC in 2005. She has extensive regulatory knowledge and experience in the policies and requirements for investment products both in Hong Kong and internationally. She played a lead role in the design and launch of various mutual recognition of funds (MRF) arrangements between Hong Kong and other jurisdictions, in particular the ground-breaking MRF arrangements with Mainland China.

Prior to joining the SFC, Ms Choi practised as a solicitor in Hong Kong and was a partner of the Corporate Group of the international law firm, Clifford Chance.

Ms Choi is currently Chair of the International Organization of Securities Commissions' Committee on Investment Management. She is also a member of the Hong Kong Trade Development Council's Financial Services Advisory Committee and the Asian Financial Forum Steering Committee.

Ms Choi chairs the SFC's Products Advisory Committee and Committee on Real Estate Investment Trusts. She also sits on the SFC (HKEC Listing) Committee and the Executive Committee.

Executive Director (Banking Conduct)
Hong Kong Monetary Authority

Alan Au is the Executive Director of the Banking Conduct Department of the Hong Kong Monetary Authority (HKMA). He is responsible for conduct supervision of banks in Hong Kong (including consumer protection and financial inclusion; sale of securities, investment, insurance and Mandatory Provident Fund products by banks; trust business of banks; bank culture; bank licensing matters) as well as oversight of financial market infrastructures.

Mr Au joined the HKMA in 2010 as Head of the Corporate Development Division. He also served as Administrative Assistant to the Chief Executive of the HKMA and worked as Division Head in the Banking Supervision Department, before taking up the present position in 2017.

Prior to joining the HKMA, Mr Au had served as an Administrative Officer in the HKSAR Government for over a decade, and had been posted to various offices and policy bureaux in the Government Secretariat including the Financial Secretary's Private Office and Financial Services and the Treasury Bureau.

Mr Eric Cheng is the Executive Director (Policy) of the Mandatory Provident Fund Schemes Authority (MPFA), responsible for formulating strategies, policies and legislative amendments to reform the Mandatory Provident Fund (MPF) System for enhancing retirement protection for the working population. He also oversees regulation, approval and monitoring of compliance in relation to MPF investments, and steers MPFA's participation in the International Organisation of Pension Supervisors.

Mr Cheng joined the MPFA in 2021 as Director (Policy Development and Research) and has been appointed to the current position with effect from 1 July 2023. Before joining the MPFA, he had been in the Administrative Officer grade with the Government of the Hong Kong Special Administrative Region, serving in various Government bureaux and departments including the former Home Affairs Bureau, Education Bureau and Financial Secretary's Office, and on secondment to the Organisation for Economic Co-operation and Development.

Mr Cheng holds a master's degree in public policy from the University of Oxford, and a master's degree in economics and a bachelor's degree in actuarial science from the University of Hong Kong.

The former Chief Justice of Hong Kong

The Hon Geoffrey Ma GBM is the former Chief Justice of Hong Kong, having retired from that position in January 2021. He is now a professional arbitrator and mediator.

Prior to joining the Hong Kong Judiciary, he was in private practice as a barrister at Temple Chambers. He practised mainly in commercial, company and public law, including arbitrations. He was Head of Chambers before his appointment as a Judge of the Court of First Instance of the High Court in 2001. He was elevated to the Court of Appeal in the following year, and appointed Chief Judge of the High Court in 2003. He served as the Chief Justice of the Court of Final Appeal from 2010 to 2021.

He is the Editor in Chief of Arbitration in Hong Kong: A Practical Guide (1st to 5th editions). He is also a member of the International Advisory Board of the Hong Kong International Arbitration Centre, on their Panels of Arbitrators and Mediators, and is also on the Panel of Arbitrators of the Singapore International Arbitration Centre. He is also a door tenant of Brick Court Chambers, London and has offices in Singapore.

Mr. Jason Fong was appointed as the Global Head of FamilyOfficeHK, Invest Hong Kong (“InvestHK”) in April 2023. InvestHK is the department of the Hong Kong SAR Government, and FamilyOfficeHK at InvestHK is responsible for promoting Hong Kong as the international hub and preferred choice of family offices.

Mr. Fong is a veteran in the banking and asset management industry with over 27 years of experiences before joining FamilyOfficeHK. He has held various senior positions with international financial institutions over his career and he has wide exposure in the Asia Pacific region including Mainland China, Hong Kong, Taiwan, Singapore, Malaysia, Philippines, Japan and Korea. 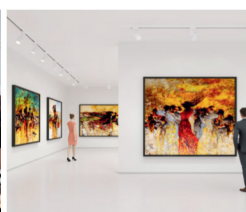
