



#### Salient features of our new website



#### **Reminder to TCSPs**

#### To carry on trust or company service business

• Apply for a TCSP licence

#### As a TCSP licensee

- Apply for the Registrar's prior approval for adding new ultimate owner / partner / director
- Notify the Registrar of changes in particulars
- Apply for renewal of licence
- Notify the Registrar of intended cessation of trust or company service business



**Transitional Period** 

#### 120-day transitional period for application of TCSP licence







- Form TCSP1 Application for a Trust or Company Service Provider Licence
- Form TCSP2 Application for Renewal of a Trust or Company Service Provider Licence
- Form TCSP3 Application for Approval to Become an Ultimate Owner / a Partner / a Director of a Trust or Company Service Provider Licensee
- Form TCSP4 Statement as regards Fit and Proper Criteria (For applicant / ultimate owner / partner / director – individual)
- Form TCSP5 Statement as regards Fit and Proper Criteria (For partner / director – corporation)
- Form TCSP6 Notification of Changes in Particulars
- Form TCSP7 Notification of Cessation of Trust or Company Service Business







- The Registrar may grant a TCSP licence if the Registrar is satisfied that the applicant and each relevant person is fit and proper
- If a licence is granted, applicant will be notified to collect the TCSP licence








Application for Approval to Become a TCSP Licensee's Ultimate owner / Partner/ Director (1)




Application for Approval to Become a TCSP Licensee's Ultimate owner / Partner/ Director (2)


#### Application for Approval to Become a TCSP Licensee's Ultimate owner / Partner/ Director (3)





## Notification of changes in particulars

TCSP licensees should notify the Registrar of changes in particulars within one month



For change in name/ business address of TCSP licensee, the new name / business address will be updated to the Register of TCSP Licensees



- Schedule A Change in particulars of Licensee
- Schedule B Cessation of being a Relevant Person of Licensee
- Schedule C Addition of a Relevant Person / Change in particulars of a Relevant Person – Individual
- Schedule D Addition of a Relevant Person / Change in particulars of a Relevant Person – Corporation
- Schedule E Change in fit and proper status of Licensee / a Relevant Person

## Notification of Cessation of Trust or Company Service Business

TCSP licensees should notify the Registrar of the intended cessation of trust or company service business before the intended date of cessation of business



- The TCSP licence will be cancelled
- The Name of the TCSP licensee will be removed from the Register of TCSP Licensees






## **Enforcement of the Licensing Regime (2)**
