Steven Gallagher is Associate Dean (Teaching and Learning). He was awarded a first class LL.B. Steven has taught equity and trusts, land law, company law, insolvency law and cultural heritage law. His research interests include cultural heritage, legal history and equity. He is currently researching issues in cultural heritage law in Asia. He is a member, Editorial Committee of the Hong Kong Law Society's journal, The Hong Kong Lawyer. Also, he is a consultant for the Department of Justice on the revisions to Hong Kong's law of trusts to be implemented 1st December 2013. Steven has presented continuing professional development courses for solicitors in Hong Kong on many topics associated with equity.
