**The speaker:** Mr. Alfred IP, the Partner of Oldham, Li & Nie, was qualified as Solicitor in Hong Kong in 2000, and was made Partner in the Dispute Resolution team in 2007. He is a notary public, a member (TEP) of the Society of Trust and Estate Practitioners (STEP), a Mediator accredited by CEDR, and a member of the Chartered Institute of Arbitrators. In March 2017, he sat as an assistant District Judge.

Since starting as a litigator, Alfred's practices extend to both non-contentious and contentious probate. On non-contentious probate, Alfred assists heirs (both local and foreign) on obtaining probate and letters of administration in Hong Kong, and administering the estate by, *inter alia*, collecting and liquidating assets for distributions, usually involving real property, stocks and shares, and other valuables. On the contentious side, Alfred successfully acts for parties in probate and related actions. Apart from propounding wills, he also advises on removing executors or administrators, seeking guardianship orders pursuant to the Mental Health Ordinance (Cap.136), and claims pursuant to the Inheritance (Provision for Family and Dependents) Ordinance (Cap.481).

With the full spectrum of experience in probate, Alfred can provide practical advice to a client's estate planning, from a properly drafted will to a complex trust situation, with the aim of avoiding any potential pitfalls that may lead to family disputes.
