With effect from 1 March 2018, a new licensing regime for trust or company service providers will come into operation. Any one who carries on or wishes to carry on a trust or company service business in Hong Kong is required to apply for a licence from the Registrar of Companies. In addition, companies are required to obtain and maintain upto-date information on beneficial ownership by way of keeping a Significant Controllers Register.
