You are cordially invited to join the briefing session on the **Summer Internship Programme** ("SIP") 2021 of the Pilot Programme to Enhance Talent Training for the Asset and Wealth Management ("WAM") Sector ("Pilot Programme").

The Pilot Programme is a government-funded project to enhance talent training to meet the growing manpower needs of the WAM sector. Commencing in 2017 summer, over 4,600 undergraduates applied for 420+ internship positions offered by our SIP participating employers("PE")s. Overall feedback from both the PEs and student interns in all years were extremely positive. As such, we have started to open winter internships to meet the requests of the employers.

The **Summer Internship Programme** offers:



A unique platform for undergraduates of 22 local <u>Higher Education Institutions</u> for summer/winter jobs search;



A centralised effort to promote your company, vacancies and receive applications; and



Subsidy of 75% or up to HK\$14,000 (whichever is lower) of the honorarium you paid for each internship position for up to eight weeks in each year.

- (iii) Trust companies registered under Part 8 of the Trustee Ordinance (Cap. 29); or
- (iv) Firms or corporate practices registered with the Hong Kong Institute of Certified Public Accountants; or
- (v) Trustees approved by the Mandatory Provident Fund Schemes Authority under the Mandatory Provident Fund Schemes Ordinance (Cap. 485); or
- (vi) Trusts or company service providers licensed by the Companies Registry under the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (Cap. 615).
