#### **The talk:**

The promulgation of the "*Civil Code*" has great significance in China's legislative process. It was revised on the basis of the original "*Marriage Law*", "*Adoption Law*" and "*Inheritance Law*" into "*Marriage and Family Part*" and "*Inheritance Part*". The promulgation of the "*Civil Code*" will have a profound impact on the wealth inheritance of high-net-worth individuals in China. Ting Zhang will talk about:

- the changes in the new code as compared with the previous laws and regulations, especially in the aspects of marriage and succession, and its impact on private wealth development.
- how the Civil Code will affect the future development of trust law.

#### **About the speaker:**

Ting Zhang is the director of International Legal Services of Docvit Law Firm. She graduated from Peking University (undergraduate) and Tsinghua University Temple Project (American Law LLM), worked as a senior auditor at PricewaterhouseCoopers International, and then as a lawyer and a partner in Beijing Dacheng Law Firm (Dentons LLP), the world's largest law firm, for 12 years. She practices in China, is qualified to practice in HK SAR, California of United States and America and also passed the MCT of QLTS of England and Wales. She was the visiting fellow of University of Cambridge in the field of China Outbound investment, especially One Belt, One Road initiative, and comparative study of Trust Law between China and UK. She is also a Guest Professor of City University of Hong Kong, a member of China Business Law Society (Trust), a member of Foreign Legal Service Research Committee of Beijing Lawyers Association, a Special Lecturer in the Trust Industry of China Banking Association, and Professional Fellow selected by the U.S. Department of State and the National Committee on United States-China Relations.
