



HKTA Webinar on eMPF

HKTA is pleased to work with the Mandatory Provident Fund Schemes Authority (MPFA) in presenting the webinar on eMPF. eMPF Platform is a common electronic platform aimed to standardize, streamline and automate the current MPF scheme administration processes, which is anticipated to bring tremendous benefits to scheme members, employers and self-employed persons in terms of enhanced user experience in managing MPF, increased efficiency in scheme administration and handling of employees' monthly contributions.

In order to perfect the design of the front-end portal, which is an essential component of the eMPF Platform, the MPFA is now conducting an extensive Stakeholders Consultation Exercise (SCE) until mid-2022 with a view to reaching out to key stakeholder groups along the MPF value chain to gauge their views and comments on the portal design so that the eMPF Platform can cater for the needs of different users. In the SCE, participants will be shown the eMPF Platform prototype mock-up simulating various scheme member and employer scenarios, and they can give their comments and suggestions from the user perspective respectively. The eMPF Platform Company and the project contractor will assess the comments received and incorporate them in the front-end portal design where appropriate.
