



# **Privacy-Friendly Awards 2023 Information to Applicants**

#### Introduction

In view of the positive feedbacks and overwhelming responses received for the inaugural "Privacy-Friendly Awards 2021", the Office of the Privacy Commissioner for Personal Data (PCPD) is pleased to announce the launch of the 2<sup>nd</sup> "Privacy-Friendly Awards 2023" (Awards). Under the theme of "Embrace Privacy Management Programme to Gain Trust and Benefits", the Awards aim to recognise the commitment and efforts of enterprises, public and private organisations as well as government departments in protecting personal data privacy and championing the importance of setting up a Privacy Management Programme.

# **Benefits of Participation**

Five designated "Privacy Protection Measures" are set as goals for organisations to achieve. Depending on the number of "Privacy Protection Measures" that an organisation has put in place or completed, a Gold, Silver or Bronze "Privacy-Friendly" Certificate will be awarded to the organisation to recognise its efforts in promoting the protection of personal data privacy.



In addition to the Gold, Silver or Bronze "Privacy-Friendly" Certificate, the awardees will be presented with one-year free membership of the PCPD Data Protection Officers' Club and specified quota of enrolment of the professional workshops organised by the PCPD. Outstanding performers will also be invited to participate in the publicity activities to showcase their achievements in privacy protection.

#### Validity of the "Privacy-Friendly" Certificate

The "Privacy-Friendly" Certificate will be valid till 31 March 2025. The validity period will be specified on the certificate.

# Criteria for Assessing Applications

Organisations should indicate whether the following Privacy Protection Measure(s) has/have been put in place or has/have been completed by the application deadline for the Awards (10 March 2023), and provide brief supporting information:

1	Discussed and recognised the importance of Personal Data Privacy		
	Management Programme (PMP) 1 at board meetings and/or senior		
	management meetings in the organisation in the past 24 months before		
	submission of the application.		
2	Have at least one Data Protection Officer (either on a full-time or part-time		
	basis) or have established a dedicated department for data protection.		
3	Have developed internal policies on personal data handling <sup>2</sup> .		
4	Have put in place a data security breach notification mechanism and a written		
	policy <sup>3</sup> .		
5	Provided training or education for staff on the protection of personal data		
	privacy in the past 24 months before submission of the application.		

# **Application Procedures**

#### **Application Period:**

The application period is 5 January – 10 March 2023.

#### **Submission of Applications:**

Participating organisations should complete and submit the online application form and relevant supporting documents on the Privacy-Friendly Awards 2023 website
