China's new data law, the Personal Information Protection Law (PIPL), came into effect on 1st November, 2021 and has significant implications for businesses. In this webinar, our speakers will introduce the key concepts of the PIPL and how they interact with other Chinese laws and regulations, explain how the PIPL will impact businesses operating in China and the region, identify areas of variation with other major data laws such as the European GDPR, and provide practical guidance on what companies should be doing to be compliant.
