Hong Kong's new competition law took effect in December 2015. The law applies to all businesses in Hong Kong, including those in the trust and fiduciary services industry. Penalties for failing to comply with the law can be severe – a company group may be fined up to 10% of its annual turnover in Hong Kong for each contravention. Individuals involved in a breach may also be penalised. It is therefore vital that businesses are aware of and comply with the law.

This talk will provide an outline of what members of the trust and fiduciary services industry in Hong Kong need to know and understand about the new law. The talk will cover:

- the competition rules (anti-competitive conduct and abuse of market power);
- key “dos and don’ts”;
- examples of conduct in the trust and fiduciary services industry that may breach competition law;
- consequences of breaching the rules; and
- practical tips for complying with the new law.

The talk will be presented by Simon Yung and James Wilkinson, both are experienced lawyers from King & Wood Mallesons, an international law firm.
