Stefano Mariani, MA (Oxon), MSc (LSE), of Lincoln's Inn, Barrister is a solicitor and barrister admitted in England and Wales, and currently a Registered Foreign Lawyer at Deacons, where he works in the tax and trusts practice. Mr Mariani is a lecturer in revenue law at Hong Kong University and a regular contributor to legal and industry publications, including the Asia Pacific Tax Bulletin and the Asia Pacific Journal of Taxation. He is a contributing author to the seminal *Encyclopaedia of Hong Kong Taxation* and an honorary fellow of the Asian Institute of International Financial Law.

This seminar will clarify and offer guidance on a difficult and much-debated area of Hong Kong tax law: the taxation of trusts and trustees. Though a great deal has been written and said on the subject, much of it may be confusing or misleading for trust practitioners. Mr Mariani will present a clear, logical, statute-driven framework to understanding the taxation of trusts and trustees in Hong Kong and dispel longstanding myths and preconceptions. The focus of the seminar is practical. It is intended to provide trustees and fiduciaries with a clear, unambiguous understanding of their Hong Kong tax law obligations with a view to assisting them, their clients, and the beneficiaries of the trusts they administer in managing their tax compliance risks in Hong Kong.
