INTRODUCTION

In December 2015, the Commission on Poverty (CoP) embarked on a six-month public engagement exercise on retirement protection entitled "Retirement Protection, Forging Ahead". It aims to gauge public views on how to improve Hong Kong's retirement protection system. The core issue of this consultation is whether the principle of "regardless of rich or poor" or "those with financial needs" should be adopted to strengthen the existing retirement protection system. The consultation paper also reviews the operation of other pillars. Another issue which needs to be addressed is the offsetting arrangement of the Mandatory Provident Fund (MPF) Scheme.

We are honoured to have Mr Matthew Cheung Kin-chung speak on this important subject, where members can express their views on the consultation.
